FedConnect has its limitations, which is why ORA maintains a single FedConnect account for all research at the University of Maryland. It's crucial to note that individual PIs or business administrators should NOT register for accounts. This is to avoid any potential confusion and misuse of resources. Searching for the Funding Opportunities

Go to www.fedconnect.net and click on "Search Public Opportunities".



Enter the FOA number from DOE, or you can search by title (for example, Type in "recovery" and click on the Search button at the end of the row). Click on the hyperlink of the FOA you wish to view.
